## DOGS ELIGIBLE TO ENTER

---

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no sign of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

## CLASS ELIGIBILITY – NOVICE A & B

---

**NOVICE A** Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.

**NOVICE B** Classes are open to all dogs.

## HANDLING MORE THAN ONE DOG

---

Handlers may **not** handle more than one dog in each class (WITH THE EXCEPTION OF HANDLER DISCRIMINATION CLASSES when offered). Multiple dogs for the same owner may be entered in the same class, provided they are run by different handlers. Please indicate handler's name on form.

## ENTRY FEES

---

An entry is defined as a single run by a single dog in a single class.

Entry fees include a \$3.50 per run AKC recording fee.

No entries will be accepted by phone, email or fax. Express mail entries must **not** be marked "signature required" therefore allowing them to be left at the secretary's address. **ILLEGIBLE ENTRIES** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. The Club will add a \$30.00 collection fee to the amount of each returned check.

**MOVE-UPS** prior for the Saturday / Sunday trials must be received in writing by the Trial Secretary no later than Tuesday, October 1, 2024 at 10:00 am. Emails are acceptable, NO VERBALS, or Texts. Move-ups will be permitted from Trial 1 to Trial 2 provided Q is earned in T1 and dog was originally entered before closing in T2 for that element.

## WAIT LIST INFORMATION

---

York County Dog Training Club will place a maximum of 20 entries on the wait list. All entries, including wait list entries, must be received by the Secretary by closing, September 21, 2024 at 9:00 AM EST. The wait list will be maintained through Tuesday, **October 1, 2024 at 9:00 AM EST**. If a withdrawn entry is replaced by a wait listed entry, a refund will be issued for the withdrawn entry. Payment/checks received for a wait listed entry that do not move off the wait list to the trial will be shredded by the trial secretary.

## REFUNDS

---

**NO FEE WILL BE REFUNDED** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**BITCHES IN SEASON** will be awarded a refund, less **\$5.00 service fee** per class processing fee. Notification in writing (including a veterinarian's certificate) must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial. Notifications in writing can be emailed to the TS if not attending the trial but must still be received 30 minutes prior to the start of the first class.

**INJURED DOGS OR HANDLERS** will not be awarded a refund after closing.

**TRIAL SECRETARY** will not be held responsible for entries or changes not received at all or not received by any deadline. It is the exhibitor's responsibility to follow up on any correspondence with the Trial Secretary before any deadline date. If you do not get an email reply from the Trial Secretary, it most likely means she did not get your correspondence and you need to try to contact her again using an alternative form of communication.

## RIBBONS, AWARDS AND PRIZES

---

Placement ribbons will be awarded in each class as follows:

A **New Title** rosette will be awarded to all dog and handler teams finishing a title. A **Level Title** rosette, **Elite Element Title** rosette and **Elite Level Title** rosette will be awarded to dog and handler teams earning these titles at these trials. Detective qualifiers will receive a special **Detective Q** rosette and those earning a Detective title will be awarded a special **New Detective Title** rosette.

### RESULTS AND RIBBONS

Results will be posted.  
Ribbons are self-service inside the building.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

## STAGING AREA, HANDLERS' BRIEFING AND WARM UP AREA

---

**STAGING AREA:** The staging area will be out of view of search area(s). Staging area will include warm-up area, waiting area, gate boards for checks-ins, Trial Secretary scoring area and posting of running order and results.

**HANDLERS BRIEFING:** The handlers briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handlers' Briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides, and maximum time for the search. NO DOGS are to be present during the Handlers' Briefing.

**WARM-UP AREA:** The warm-up area will have one labelled container per target odor being used in the trial on that day and will be placed in the designated warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well.

## SEARCH AREA AND RING CONDITIONS

---

Search areas may be of any shape and of the size specified in the Regulations for each class. Searches may be indoors, on matted, carpeted, concrete, tiled or other various surfaces, or outdoors on grass, gravel, earth, concrete, asphalt, or other various surfaces. Search Area Sizes will be as defined in the AKC Scent Work regulations.

## ADDITIONAL SITE INFORMATION

---

**TRIAL SITE:** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

**POSSESSION OF ODORS AND TRAINING:** The Scent Work Regulations state, "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area."

**SPECTATORS:** Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.

**CRATING SPACE:** Exhibitors will work from their cars. There is no crating space indoors. York County Dog Training Club is not responsible for lost or damaged items left at the show site.

**CLEAN-UP:** Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Disposal sites will be available on the show grounds.

**FOOD:** No food available on site for purchase. Please come prepared with own food & drinks. There are multiple restaurants available nearby.

## NOTICE TO EXHIBITORS

---

**SAFETY BEHAVIOR AND LIABILITY:** The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. The York County Dog Training Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children. York County Dog Training Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the York County Dog Training Club or any official thereof.

**COLLARS, LEASHES AND HARNESSSES:** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**DOGS MUST BE ON LEASH AT ALL TIMES.** Retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

**RINGSIDE: Judges are not required to wait for dogs.** The owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The club has no responsibility to provide service through a public address system, or stewards or runners, for the purpose of calling or locating dogs that are not brought into the ring when required.

**EXHIBITOR CHECK-IN:** Exhibitors must check-in for each class each day they are entered.

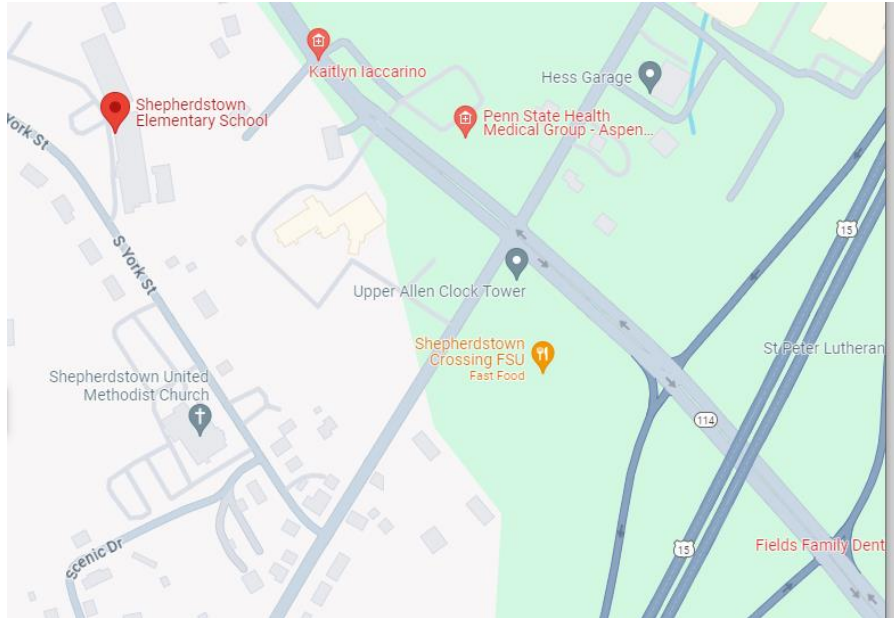
