- **SUNDAY 12/29 SET UP: 5:00 pm** – Building closes at 7 PM
 - We will need help with unloading the equipment trailer and setting the course if anyone can lend a hand. Thank you in Advance!
- **DOORS OPEN:** 6:45 am daily
- **TRIAL HOURS:** 6:00 am – 30 minutes after the conclusion of trial each day
- **MEASURING: NOT OFFICIAL** – No height cards will be issued unless an AKC Rep would happen to be present at the trial which at this time is unknown to us. Measuring starts 7:30 am daily. Judge of record will measure any dog required to be measured before the trial or in between classes throughout the day as they have time.
- **CRATING:** Crating on the turf requires tarps / matting under all crates.
 - Crate aggressive dogs are not to be situated near any rings or busy walkways. This includes outside in vehicles as well.
- **FOOD:** No food available for purchase on site

From 322 West: Take Rt. 322 West toward State College. Exit at the Research Park/Hospital Exit. **Make a right onto Park Avenue. Right at light on Fox Hollow Road which changes name to Fox Hill Rd, then Left on to Bernel Rd, Left on Champion Drive.

From Interstate 80, Exit 161: Take Rt. I-99 South. Then take **Exit 74 Innovation Park/Penn State University** Exit. Stay in left lane for PSU/Beaver Stadium. This lane becomes Park Avenue. Right at light on Fox Hollow Road which changes name to Fox Hill Rd, then Left on to Bernel Rd, Left on Champion Drive.

From I-99 N: Take **Exit 71 (Toftrees / Woodycrest.** – Turn left on to Waddle Rd, then right onto Toftrees Ave. Left onto Cricklewood Drive. Left onto Fox Hill Road. Then Left onto Bernel Road. Turn Left on Champion Drive.
